The 10-year guarantee will be sent to you once the final payment has been received.

Contract – the agreement entered into between Us and You for the building work.

**Defect** – any materials supplied under the Contract that do not perform to their specifications and/or building works that do not meet the specification or standards expected under the Contract.

**Guarantee period** – 60 months from the date of completion of the building works under the Contract.

**Location –** The property situation in the United Kingdom. Channel Islands or Isle of Man.

# What is covered and for how long.

All of our projects are covered by an insurance backed 10-year guarantee. We are responsible for assessing the defect and if covered we will repair the defect. You must not attempt to repair the defect by yourself or by appointing a third party to do so. If You do this Your guarantee will be void.

- General building works and materials Steels, Bricks, Timber Etc... 10 years of cover.
- Flat roofing Felt 3 Years.
- Flat roofing Epdm 5 Years.
- Flat roofing GRP 10 Years.
- Windows 10 Years.
- Electrical wiring and installation 5 years of cover.
- Plumbing pipe works 3 years.
- Drainage 5 Years Does not include blockages.
- Outside render 3 years, must be maintained yearly.
- Kitchen units Only covered by manufacturers guarantee.
- Sanitary ware Only covered by manufacturers guarantee.
- Electrical appliances Only covered by manufacturers guarantee.
- Electrical fittings light fittings, plug sockets, light switches, extractors 1 Year manufactures guarantee.
- Boilers Only covered by manufacturers guarantee.
- Wooden flooring Only covered by manufacturers guarantee.
- Internal Doors 1 Year.
- Ironmongery 1 Year.

### What is not covered.

- New build properties or buildings.
- Standard refurbishment works.
- Intentional or accidental acts by you.
- Any amount that is recoverable by you under any guarantee, warranty, maintenance and rental hire or lease agreement.
- Consequential loss of any type.
- The first £200.00 of any claim that has to be paid by You before any claim will be processed.
- The swelling or shrinkage of any wooden doors.
- Any damage caused by 3rd parties.
- Any damage caused by adverse weather conditions.
- Any subsidence caused by heave or ground slip.
- Any items or materials not supplied by us that have failed in any way shape or form.
- Any items that are damaged through wear and tear.
- Settlement cracks in plaster finishes.
- Any electrical or mechanical items covered by a manufacturer guarantee.
- Any items covered by a manufacturer guarantee.

- Inception date of cover.
- The nature of the Defect.
- How and when we can get access to assess the defect.



#### **GENERAL CONDITIONS**

- 1) We will make all reasonable attempts to provide the provision of service except where it is precluded by:
  - a) Adverse weather conditions.
  - b) Industrial disputes (official or not);
  - c) Failure of the public transport system (including the road network) and repair thereto.
  - d) Other circumstances preventing access to your location or otherwise making provision of cover impractical.
- 2) We shall be entitled to:
  - a) Decline cover if in our opinion the location or services have not been maintained in a sage or serviceable condition.
  - b) Decide on the most appropriate means of providing cover although we will take your wishes into account whenever possible.
- 3) You will be responsible for any charges if having requested assistance if a defect cannot be found with the Contract.
- 4) If you request any additional work to be undertaken you will be responsible for the additional costs.
- 5) We shall not be responsible for any inconvenience, loss or damage caused by delay in the supply of replacement materials or labour.
- 6) In the event that the materials are no longer available we will provide a replacement product based on the same or similar specification.
- 7) This guarantee is governed by and construed in accordance with the Law of England and Wales.
- 8) All benefits under this guarantee will be lost if a claim under this guarantee is made that is false or dishonest in any way.
- 9) In the event that there is another warranty in force veering the materials and/or work supplied under the Contract then we shall only pay our rateable proportion of any claim under this agreement.
